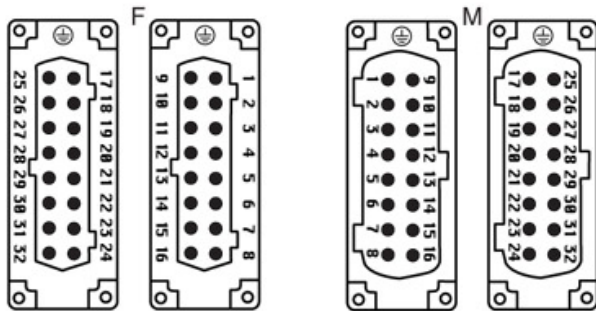
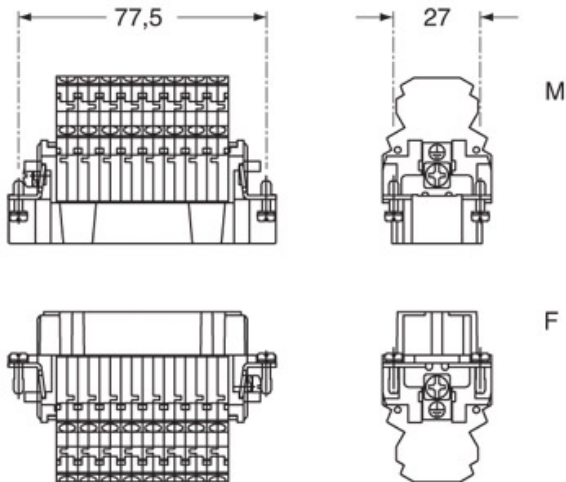
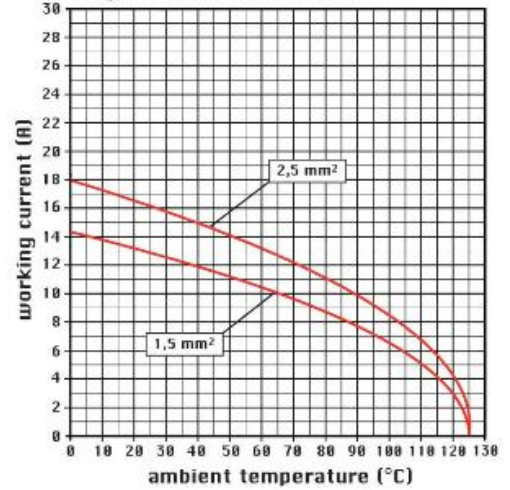
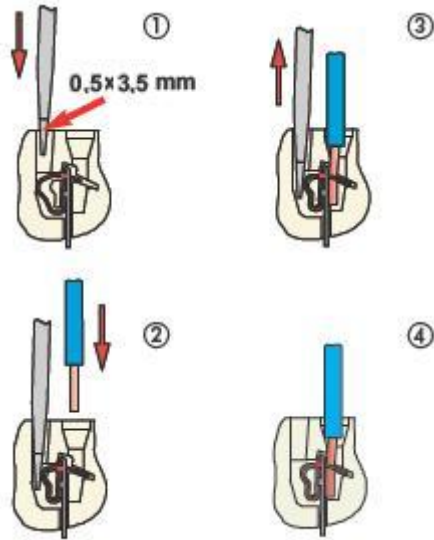


diagram CSS 16 and 32 poles
